Co-created a joint Deep Blue Grants Programme as a partnership between the Seychelles Conservation and Climate Adaptation Trust (SeyCCAT) and Nekton. Seven Seychellois researchers were funded to participate in the expedition and conduct deep water research to inform the national marine spatial plan and local conservation initiatives.

Devised and co-created the "AfOx Marine Science Fellowship" as a partnership between SeyCCAT, Nekton and the University of Oxford's Africa Oxford Initiative. Two female Seychellois researchers were awarded visiting fellowships to Oxford University, as part of a small cohort of early-career researchers from across Africa.

As Head of Finance, co-authored Nekton's strategy and business plan, including preparing associated budget scenarios. Managed the charity's finances and governance. Supported the Chief Executive in all fundraising activities, including researching new opportunities; creating pitch decks and connecting Nekton with the Blue Prosperity Coalition.
